

Flora/Unilever – Recipe Submission New Zealand

Terms and Conditions

1. Information on how to submit a recipe to the Flora/Unilever site forms part of these Terms and Conditions. Submission of recipe/s to the Flora/Unilever Recipe database is deemed acceptance of these Terms and Conditions.
2. To successfully submit recipe/s to be published on the site, entrants must:
 - go to the Flora Website at <http://www.floraloveyourheart.co.nz/Public/recipes/RecipeSubmit.aspx> (“the Website”);
 - validly complete the on-line submission form by providing your full name, email and state
 - complete all mandatory fields for submission of your recipe, serves, preparation time, cooking time, recipe type, Flora/Unilever product used, ingredients and method
 - read and accept these terms and conditions;
 - upload one electronic image depicting “recipe”; and
 - submit recipe by clicking on ‘Submit’.
3. The entrant agrees to indemnify Flora/Unilever against all costs and claims by third parties arising from a breach of this warranty. Entrants consent to any use of their entry which may otherwise infringe their moral rights pursuant to the Copyright Act 1968 (Cth).
4. Flora/Unilever take no responsibility for the entrant submitting an image and / or recipe that has been reproduced from a third party or taken from elsewhere and infringes on the Copyright Act 1968 (Cth)
5. By participating in submitting a recipe, each entrant, as the copyright owner of the recipe and photograph, grants a worldwide, royalty free, licence fee free in perpetuity to Unilever New Zealand Ltd to, without further consent from the entrant:
 - reproduce the Original Recipe and Photograph and communicate it via the Website
 - reproduce the Original Recipe and Photograph and communicate it via any mobile media (including by way of mobile file download via MMS);
 - exhibit any information (other than address details) provided by the Entrant and the Original Recipe and Photograph, for promotional purposes in relation to the Promotion in any form of media that the promoter may chose; and
 - exhibit the Original Recipe and Photograph in public or over the internet to promote other events and competitions sponsored by Unilever Australasia.

10. Flora/Unilever reserves the right to modify the submitted Recipe and Photographs as necessary to facilitate commercial printing and reproduction requirements, without consultation with the entrant.

Flora/Unilever reserves the right to verify the validity of entries and to reject any recipe which, in the opinion of Promoter, includes objectionable content, profanity, potentially insulting, inflammatory or defamatory statements, disqualify any entrant who tampers with the entry process, who submits a recipe that is not in accordance with these Terms & Conditions of Entry or who has, in the opinion of Flora/Unilever,

Flora/Unilever reserves the right to edit/remove an entry if they become aware that the submitter or the submitters' entry is of a type described in this clause.
